Short Application Guidelines and Key steps in the processing of an application for Consent to Mortgage (MOT)		
1. An EDL Title Holder who wants to apply for Consent to Mortgage must apply with this MOTI form.		
2. The Applicant must also complete a UCI or UCO form with the details of the Bank (Mortgagee).		
3. The Consent to Mortgage attracts an Application Processing Fee of N50,000 . This Payment is non- refundable and must be paid into EDOGIS Paydirect account at any commercial bank. The Bank Teller/Receipt must be submitted together with the completed Application Form.		
4. Fees for Registration and Stamping will be applicable once the consent has been approved. These are 0.5% of the Consideration and Added Amount respectively. The amounts will be communicated as soon as they become due.
